The 2008 ALS/BLS Competition Committee is encouraging all potential judges to submit this form along with a copy of their **current resume & a digital photograph** to Wesley Houtz via fax or email to 407-281-4407 or [whoutz@emlrc.org](mailto:whoutz@emlrc.org), respectively, by April 11, 2008. The competition committee will review all resumes and notify selected judges by the end of May.

The Committee has adopted the following qualifications for judges for the 2008 competition:

- Five years in prehospital care or emergency medical care to include teaching experience.
- Licensure or certification as either paramedic, RN, PA, MD, DO, or DMD
- Minimum of provider level in ACLS and BTLS or PHTLS
- Instructor in ACLS or BTLS or PHTLS
- Recommend pediatric or neonatal certification as provider or instructor.

Judges who have judged less than 4 years will be required to attend a meeting on Tuesday evening, July 8, from 8pm - 10pm. There will be another meeting on Wednesday, July 9, at 7:00am for **ALL JUDGES**. You are expected to participate from 7:00am until approximately 4:00pm on Wednesday, July 9, 2008. The ALS/BLS Competition and ClinCon are being held at The Rosen Centre in Orlando, FL. Breakfast, Lunch and refreshments will be provided on Wednesday, July 9. *Note: If you are unable to participate for this time period, we ask that you not request to judge.*

The registration fee for judges attending **CLINCON 2008** will be discounted to **\$225** (this does not include pre-conference seminars).

**Please let others know of this opportunity since we are always looking for new judges.**
